## 7. TUITION FEE ANALYSIS REPORT 2022-2023

- The Registrar reviewed the report page by page, thanked the IR Team for their work on the report and noted:
  - The guiding principles for development of tuition and fees are based on the college's Strategic Plan;
  - Selkirk has the lowest international tuition in the provincial college sector;
  - Selkirk's affordability satisfaction declined last year, noting this decline aligned with a jump in inflation.
  - Most students choose Selkirk on program fit.
  - o The analysis report will be shared with the Selkirk College Students' Union.
- Discussion ensued on the tuition increase limit of 2%.

## 8. TUITION FEE BYLAW NOTICE OF MOTION

#### 9. QUARTERLY FINANCIAL REPORTS

- The Executive Director of Finance & Risk reviewed the circulated report noting;
  - o The Q3 Report went to the ministry in late December reporting a \$2.3M deficit;
  - Highest earning period is September to March;
  - Government grants trending as expected, along with sales;
  - o Better investment income from the investment of grants received ahead of time in full;
  - Expenses higher than the last few years
- Have not heard from Ministry on deficit approval for 2023 and 2024.

#### 10. 2023-2024 BUDGET DEVELOPMENT UPDATE

- The Executive Director of Finance & Risk provided a verbal update:
  - Work is underway to move last year's budget information into the Unit4 Planner module;
  - The President presented a virtual Town Hall today for employees focused on the budget development process;
  - A supervisors budget meeting is scheduled for February 22<sup>nd</sup>

#### 11. SELKIRK COLLEGE FOUNDATION

- The President reported:
  - The November 2022 Gala was a big success raising approximately \$30,000;
  - The Foundation Board and the College Board will be invited to a strategic planning session in the coming year to develop the Foundation's Strategic Plan.

#### 12. EQUITY, DIVERSITY & INCLUSION

- The President stated:
  - A joint EDI Committee meeting will take place in early February to discuss the launch of the EDI Plan and tracking methods;
  - Selkirk College is a participant of the 50-30 Challenge.

#### 13. THESES/ERP

- The President Reported:
  - A new charitable ledger and awards management system (Blackbaud) went live last week;
  - The student module launch date continues to be October 2023.

#### 14. PRESIDENT'S REPORT

- The President and members reviewed the written report. The President noted:
  - o Transit was raised as an issue during a meeting with the Students Union;
  - Discussed at campus conversations with employees: casual topics, student housing, sharing information on leadership decisions.
